		 So, My questions are as follows: It is mentioned that the Company has 78% more revenue in comparison to previous year, I just wanted to know that how sustainable will it be in the future, what is the roadmap and whether it will continue to be at that same percentage or more than that? And another question which I want to ask is, whether all the revenue will be from US only and what are the plans?

17	Mrs. Reshma Budhia	Thank you, Jayan. Mr. Y Gaurav, thank you for coming and attending our AGM and also thank you for actually registering to come here and share your questions with us. It's always nice to know that people are following and its always nice to know that they are interested. You are absolutely right to ask if the growth percentage is sustainable, for us the growth has been driven heavenly from our IPO, because that strengthened our credibility, that helped us onboard a lot of the senior marketing leadership, and we were also able to invest in Al tools like you just heard Mr. Jayan talk about, Etch and Kathai. Because of this we were able to actually elevate our CMO retainers from an average of \$3,000 to about an average of \$8,500. And that is where that growth has come in for us. And we hope with all the future deals, that we continue to sign and all the aggressive investment we will make in our Al and leadership, I am really hoping that we will be able to scale operations and sustain this. FY25 was definitely extraordinary, and we are hoping for FY26 to have that measured growth because of these timely investments and because of this value based pricing that we are able to offer to our clients. Today US is definitely a significant part of how we've been reaching out to customers and where we've been reaching out to customers, but what is good to know is there is a diversification in terms of the vertical, in which we are penetrating, we've been very strong in the B2B text space but now we are also venturing into the whole B2B Education Space. We have clients, we have interest and we are acting as the CMO office, so this vertical diversification is what we will look at, within the region. Of course, geographically we are not



		going to be doing any cold outreach because that's very expensive and instead trying grow through partnerships, so I'm hoping that we can actually hold on to US being our primary market but diversify in terms of our verticals.

		What is the way looking forward for this Company, pertaining to US tariff and how do you look up the US markets and other markets?
21	Mrs. Reshma Budhia	Sure, Thank you Mr. Deepak for asking question about the way forward, I think even the Chairman has covered it in his presentation and that is also something that we are all working towards and that's also the kind of penetrating into what Mr. Gaurav was asking, whether there is a high dependence on US as a market and how are the factors like tariff, are going to impact us? I understand from our customers conversations that, that we are still in that space where clients need us to continue to grow their business. It is really not about us taking away anything from anybody, we are value added service providers, where we are augmenting the existing team, so that there is always a complimenting factor that we bring to the table and we will continue to add value despite any of the geo-political situations that may arise anywhere for that matter, but also at the same time from an investment point of view we are growing our strength by hiring strategic leadership roles in new verticals so that we are not dependent on the same vertical, we are not only talking tech and we are also talking non-tech, we are also talking education, then we are exploring a whole out of partnership where they can open up their captive audience to us and therefore we have this ready audience that we can speak to, so we are taking very calculated steps into these initiatives, we are hoping that the road ahead is going to be onwards and upwards. So, I hope that helps address your question Sir.
